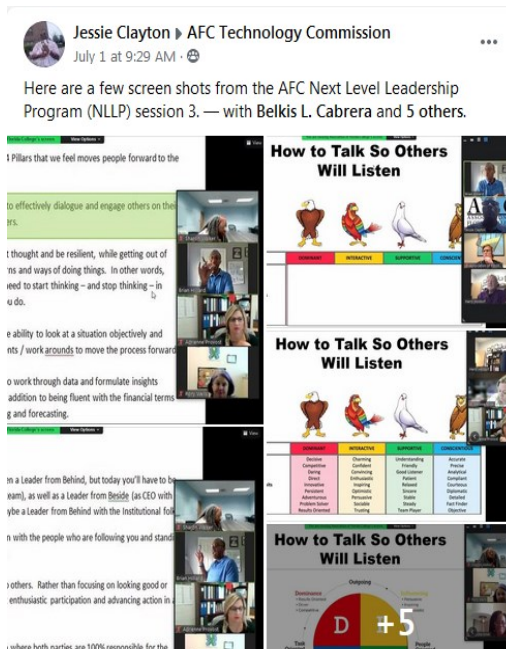

7. **SOCIAL MEDIA** (Maximum 30 points)

8. **COMMISSION CHAIR AFC BOARD OF DIRECTORS MEETING ATTENDANCE** (Maximum 20 points)

9. **AFC BOARD OF DIRECTORS WRITTEN REPORT** (Maximum 20 points)

10. **FUNDRAISING ACTIVITIES BY COMMISSION** (Maximum 30 points)
